Overlook Water Co-Op Board Meeting Minutes 18 April 2024

Meeting Location: Placitas Community Library

- 1. Meeting called to order by Dwight Bozarth, quorum verified, and agenda topics (attachment 1) presented.
- 2. Minutes from 19 February 2024 board meeting read, accepted without revision, and entered into the record (attachment 2).
- 3. Board questioned the availability of February and March JnJ reports. Dwight B. to inquire regarding status.
- 4. There have been three water leaks resulting in large bills to residents. Each has been amicably resolved.
- 5. Available operating water co-op funds as of the end of March are approximately \$54.1k.
- 6. A proposed spending plan will be developed upon agreement of necessary water system maintenance actions resulting from this meeting.
- 7. The Board decided to request JnJ test the fire hydrants upon presentation and approval of a plan for work to be accomplished.
- 8. Decision was made to remain with the existing chlorine tank and setup for the next several months. No actions other than to be cognizant of chlorine results to ensure compliance with state regulations.
- 9. Board approved Steve W. to order a new enclosure for Well 1 control system. Approval for installation operation remains an open action.
- 10. JnJ will be asked to evaluate existing system Pressure Regulation Valves (PRV) and propose maintenance plan with costs to the Board.
- 11. Options discussed for overhaul of the North pump.
- 12. The Board discussed options for Block 3 lot owners regarding their water supply options. They can a) buy into OWC for \$5k followed by their assumption of costs for excavation, laying of water line and connection, or b) the lot owner can choose to obtain their own water supply, such as hauling or drilling.
- 13. There was an extensive and detailed engineering discussion regarding the known corrosion of the pipes emanating from the tanks leading into the pumphouse, especially

the East tank. Options for addressing this problem will be developed and presented to the Board for consideration by Gary Z. and Steve W.

- 14. Next meeting is to be planned for June dependent upon availability of essential board members.
- 15. Meeting was adjourned.

Meeting Location: Placitas Community Library

- 16. Meeting called to order by Dwight Bozarth, quorum verified, and agenda topics (attachment 1) presented.
- 17. Minutes from 23 January 2024 board meeting read, accepted without revision, and entered into the record.
- 18. Hilde P. reviewed financial status of the water co-op. Small deficit noted during winter months due to low usage. Discussion of raising customer rates to ensure positive income year round. No decision on this proposed action other than to revisit soon after board review of Attachment 2 and 'Prioritized Vote Tally' (included herein).
- 19. Major system water leak detection device discussed. No decision made; further investigation of options will be pursued.
 - a. Two homes experienced major leaks during the month of January. Owners were informed will follow-up actions in progress.
- 20. Discussion of well-to-storage tank signal lines due to risk of only a single copper wire pair in operational status. Wireless communication device options are being considered.
- 21. Maintenance/repair/replacement list (attachment 2) discussed at length. The existing water system is 30+ years old and is significant risk of failure if actions are not taken to address highest risk components.
- 22. Tentative list of actions per board member recommendations:
